About the Program: The La Brea Tar Pits Presented by John Harris

The La Brea Tar Pits constitute one of the world's richest Ice Age fossil sites. The Page Museum's collections include more than 5 million fossils representing over 600 species of animals and plants. These provide a detailed record of life in the Los Angeles Basin during the waning phases of the last Ice Age.

Natural asphalt from the La Brea Tar Pits was used for various purposes by Native Americans and early European settlers. Fossils weren't recognized from the asphalt seeps until the late nineteenth century. Excavations in the early twentieth century documented prolific elements of the iconic late Pleistocene megafauna and the tar pits became the type locality of the Rancholabrean North American Land Mammal Stage. More recent studies have focused on the behavior of the extinct mammals, the habitats present in the Los Angeles Basin during the late Pleistocene, and the changes that have taken place as the area experienced global cooling and global warming.

John Harris was born and raised in London, England. He received his B.Sc. (Hons) from the University of Leicester, his M.A, from the University of Texas, and his Ph.D. from the University of Bristol. He became Director of Paleontology at the National Museum of Kenya in 1971 and was subsequently appointed Chief Curator of Earth Sciences at the LA County Museum of Natural History in 1980. He recently retired from the county although he retains the position of Chief Curator Emeritus at the Page Museum of La Brea Discoveries. During much of his career his research focused on the mammals associated with early humans in Africa. More recently he has become fascinated with the animals that inadvertently became trapped in the tar pits—an awful way to die but a wonderful way to preserve fossils!

MEANDERINGS FROM THE PRESIDENT by Ann Meister

It happened again – parking tickets on windshields at the June meeting, including one guest and one member who had the MSSC pass on the "wrong" side of their dashboard. The tickets along with locking the building door so that people have to pound on it to get someone's attention, is what the campus security is doing to annoy us. Perhaps when we are sufficiently annoyed, they think we will move to a new venue? Actually, that would potentially allow us to meet on a night other than Friday. For those of you who stay at home on the second Friday of the month, what would prompt you to attend a meeting? Leslie is putting a questionnaire on the website. Let us know. Historically, the first meeting of forty interested people was held on June 23, 1931 at the Pasadena Public Library, where the Society continued to meet on the second Monday of the month. In the November 1931 *Bulletin*, President John Renshaw remarked that the attendance had grown to the capacity of the room, nearly 200 people which is what I remember from the 1950's. In the 1960's we moved to McCurdy Nature Center at Eaton Canyon Park with meetings still on the second Monday. That move allowed us to have a social hour with refreshments after the meeting and not to be limited by the Library closing time. After the Altadena Fire in October 1993 when McCurdy was consumed, we moved to the LA County Arboretum in Arcadia and the meeting night moved to the second Wednesday. In May 1999 we moved to PCC and the second Friday where the meeting was considered a joint activity with the PCC Dana Club. All other nights, the room is in use and parking is difficult. The rebuilt Eaton Canyon Nature Center does have an auditorium where other groups such as the Audubon Society and Sierra Club meet. Perhaps we should take a look...

I did not click on the embedded links since this is not safe, but I did research the email address domain. Curiously, the domain which I will disguise as, meso\$irsk, is observably a miss-spelling of meso\$risk which I found intriguing. The domain meso\$risks is for sale for (only) \$1,895. On a website that checks for phishing, meso\$irsk was listed as non-malicious and a screenshot of the site's home page showed links to many mesothelioma resources such as lawyers, treatment, news, etc. Whether this is phishing or not, it is fishing for potential clients for lawyers to dig into the pot of \$\$\$ that Justin told us about.

Oh boy! Another California disaster movie: *San Andreas*. Just in time for your summer viewing pleasure, but don't blink, you may miss it – in fact, by the time this is published, it may already be gone. According to the blurbs, it's "So big it will be felt from California to the East Coast. So big it will rock the Richter Scale at numbers never seen. So big it will turn Hoover Dam into a soggy rock pile and threaten to immerse the Golden Gate Bridge under a wave of biblical proportions." Many errors (or per the Producer, "embellishments") in this one. The experts said that their look at the *San Andreas* trailers suggests that the film and science will diverge in several places. MINUTES of the June 12th, 2014 Meeting

The 922nd Membership Meeting of the Mineralogical Society of Southern California (MSSC) was held Friday, June 12, 2015 at Pasadena City College's Geology Department. The meeting was called to order at 7:35 p.m. by President Ann Meister.

Regular Business

- President Ann Meister welcomed all members and guests.
- A **Motion** to approve the Membership Minutes of May 15, 2015 as published in the *Bulletin* for June 2015 was made by Linda Elsnau and seconded by George Rossman. Motion was approved by unanimous vote of the membership.
- Deadline to submit items for the *Bulletin* is Monday, June 22, 2015.
- CFMS Director, Jo Anna Ritchey, is attending their convention in Lodi, CA.

Announcements

- MSSC's annual picnic will be August 9, 2015 at the Carter residence and will be from Noon 4:30p.m. The theme for the picnic is Favorite California Mineral. More information is forthcoming in the next *Bulletin*: swap tables, RSVP information, what to bring, etc.
- Next Board Meeting will be Sunday, September 13, 2015 at 1pm at the Carter residence. All are welcome to attend
- The first annual L.A. Urban Nature Fest at Natural History Museum of Los Angeles will be held on June 27 and 28, 2015. Rudy Lopez, Program Chair, is organizing MSSC's participation for the event. Rudy reports we will have an 8' table for MSSC outreach. He also says that he is still looking for volunteers to help. Show & Tell

- Bruce Carter had a newsletter about Michigan coppers and other things.
- Marek Chorazecwicz had extra specimens of Gold Hill minerals from the NCMA Micromount Symposium give-a-way table. He had also received a package of minerals from Freiberg, Germany for us to look at.

Program

Program Chair Rudy Lopez introduced the night's speaker, Justin Zzyzx. Mr. Zzyzx's presentation was <u>The Fight to Save Our State Rock, California Serpentine, and How We Won</u>.

California was the first state to have a State Rock. With lobbying by the California Federation of Mineralogical Societies, the California legislature declared serpentine the State Rock in 1965. Serpentine is greenish to brownish to black with a waxy or greasy feel. Peridotite metamorphoses to serpentine, which is actually a family of magnesium silicate minerals. It is found the Coast Ranges, Klamath Mountains and Sierra Nevada foothills. Sparsely vegetated areas are often "serpentine barrens." Ten percent of CA wildflowers only grow in serpentine deposits. It is used as a replacement for jade in the lapidary arts.

State Senator Gloria Romero, on the urging of the Asbestos Disease Awareness Association, introduced a bill SB 624 to drop serpentine because it supposedly contains the carcinogen asbestos. There are two forms of asbestos: Crysotile which occurs as fibrous veinlets in serpentine and amphiboles such as anthophyllite and amosite. Justin showed pictures of both forms side-by-side. There is a marked difference between the two.

The amphibole forms of asbestos are brittle, with the cleavage fragments forming sharp daggers that do not dissolve in acid. This is the most common form of asbestos that was used for insulation and other industrial applications. When inhaled, usually as a fine dust from mining and processing, it lodges in the lungs and cannot be removed. This causes the disease mesothelioma.

Crysotile bends and warps like a human hair; it dissolves readily and has a 14 day life in the body. It is not widely used for asbestos products.

Scientists, including George Rossman, spoke out against removing serpentine as the state rock. Ultimately, the bill failed. Had the bill passed, the lawyers could potentially have sued museums, builders who use serpentine as a decorative stone, and property owners. Under the Twitter hashtag #CASerpentine, Justin wrote, "Dear Gloria Romero, you have picked the wrong nerds to mess with!"

After his presentation, Mr. Zzyzx answered questions from the audience.

MSSC Board Meeting Minutes, June 7, 2014

- 1. Call to Order and Roll Call: The Mineralogical Society of Southern California (MSSC) Board meeting was called to order at 1:02 p.m. by Board President Ann Meister. After Ann's welcome, the Roll Call of Board members was taken. Those present were Ann Meister, George Rossman, Jim Kusely, Angie Guzman, Bruce Carter, Jo Anna Ritchey, Leslie Ogg, Pat Stevens, Linda Elsnau, and Rudy Lopez. Excused were Bob Housley, Cheryl Lopez, Geoff Caplette, Pat Caplette and Al Wilkins. Visitor: Fred Elsnau. Thank you to Bruce and Kathy Carter for again hosting the meeting.
- 2. Minutes: There was a Motion from the floor by Jo Anna Ritchey and seconded by Leslie Ogg to approve Amended Board Meeting Minutes of March 1, 2015 as published in the April 2015 Bulletin with the following spelling corrections: Ann Meister pointed out 2 spelling errors: (1) Section 3.7, Webmaster Report, Bussy should be Besse and, Section 3.8 PMC Chair Report, in the Motion, Rosa should be Rose. The vote to approve the Amended Board Meeting Minutes passed unanimously.

3. Old Business and Committee Reports

- 3.1 President's Report:
- (1) MSSC as a Donor: Ann Meister, directing her comments to Bruce Carter, who was not in attendance at the last Membership Meeting, expressed her surprise when she noticed MSSC was not listed as a donor in the program for the fundraiser hosted by and for the Pasadena City College Foundation. [You may recall that during our last Membership Meeting, Mr. Mosesson's presentation on Wello Opals was interrupted by loud sound checks outside our meeting room window]. Bruce Carter responded by saying he will make sure it is not overlooked in the future:
- (2) <u>Policy and Procedures</u>: Rudy and Cheryl Lopez have already prepared their Policy and Procedure "how to" segments. Everyone else on the Board is asked to e-mail their draft to other members of the Board for review and when completed, the procedure manual can be compiled. **Discussion on this item is tabled until next Board meeting**;

Aside from the board seats, there are 3 Director positions available for the 2-year term 2016-2017. - (4) <u>Membership</u>: Discussion regarding how we can increase our membership, why people don't come to meetings, outreach to PCC Geology staff and students (Bruce will speak to the professors again);
- (5) Meeting locations: Discussions about meeting locations, open houses, workshops, workgroups and,
- (6) <u>Reaching Members</u>: Discussion about possibly using PCC's Skype system to reach those who can't make it to meetings, put questionnaire in *Bulletin* and/or website, mention in Meanderings column, lectures on disc. Face to face socialization is important.
- 3.2 Treasurer's Report:
- (1) <u>Fund investments</u>: Jim Kusely reports there are funds just sitting not earning much interest that he would like to speak with Financial Advisor (Ida) at Merrill Lynch about investing in something more aggressive. Patrick Stevens was able to shed some light on taxable income investments. He offered to help the Treasurer but is not authorized to be spokesman for MSSC. Jim will proceed and get a few quotes;
- (2) ½ price for Membership: Discussion regarding policy of offering ½ price membership starting in July. The Los Angeles County Museum of Natural History's Urban Fest at the end of June was mentioned as a great place to offer the membership discount. A MOTION was made by Linda Elsnau and seconded by Ann Meister

to allow the ½ price membership beginning after the June 2015 Membership meeting until the end of the year. This includes ½ price for the paper *Bulletin* through the end of the year, as well. The motion was voted on and passed unanimously by the Board;

- (3) Forms: More membership forms need to be printed out;
- (4) <u>Backup copies of the books</u>: Jim made the suggestion that someone has a backup of MSSC books on CD-ROM or other media (i.e., flash drive). Secretary Angie Guzman offered to safe keep the CD backup (exact copy of Treasurer's records). The CD Jim handed over to Angie is labeled 6/7/15.
- 3.3 Federation Director Report:
- (1) Convention in Lodi: Jo Anna Ritchey will have a report after the convention this week in Lodi, CA.,
- (2) Questions/Comments: Jim wants a selfie for the Bulletin; CFMS website is not up to date; no new director yet.
- 3.4 Membership Chair Report:
- (1) <u>New members</u>: Cheryl Lopez was excused so her report was given by Rudy: 1 new family became members;
- (2) <u>Roster</u>: Discussion snail mail vs. e-mail and legal issues. Ann suggested putting footer on each page of the Roster rather than just on the cover page. Rudy said he could do that. Cheryl should look at her budget to see if she can print 20 or so more. Jim said he did not get the mailing but has one now.
- (3) <u>Brochure</u>: Discussion includes printing more for Jo Anna to take to Lodi, some items need to be edited, make sure reader is directed to website for meeting updates and include next year's schedule of dates.
- 3.5 Programs Chair Report:
- (1) <u>Speakers</u>: Rudy Lopez reports that we have speakers booked through the year. There is one change, the Forestry Service will be in December and Mr. Harris from the Page Museum (La Brea Tar Pits) will be in July we may get a field trip to the archeological dig and possibly the back room tour;
- (2) <u>Invite other clubs</u> to our Picnic and meetings: Rudy may give formal invitation to other clubs, i.e., MOROKS, Culver City Rock and Mineral Club, etc.
- (3) <u>MSSC Speakers</u>: Bruce Carter will be our speaker for the January 2016 Installation Banquet providing a new presentation and, George Rossman will be later in the year. Overall, we have speakers almost to June 2016.

[George mentioned the Forest Service, L A County Film, BBC and others are forbidden from filming in the San Gabriel National Forest because of concerns about illegal mining and endangered species in the canyons.]

- (4) <u>Urban Fest</u>: Urban Fest volunteers are Jo Anna, Rudy and Dale Harwood, so far. E-mail Rudy to be put on the list. Rudy will bring microscope, samples to show on laptop, flyers, *Bulletins*, brochures and applications for Membership. The Urban Fest is June 27-28 9:30am to 5pm;
- (5) <u>Printing costs</u>: Flyers, brochures, applications and *Bulletins* need to be printed for this and other events. Jim mentioned there is a \$20 credit Rudy can use. **A MOTION was made by Jo Anna Ritchey and seconded by George Rossman for Program Chair's printing expense, including paper, not to exceed \$125. The vote was taken and the motion passed unanimously by the Board;**
- (6) <u>Field Trip</u>: Field trip to UCLA Meteor Gallery will be Saturday, October 18, 2015. The tour is free but there is a parking fee. Discussion followed to consider carpooling to save money. More information will be forthcoming.

Break at 2:25pm. The meeting was called back to order by President Ann Meister at 2:40pm.

Ann brought up <u>Speaker Fees</u>: Should we pay them what they ask or should we pay them what we normally pay? After discussion, the consensus was we should pay what we normally pay (\$150). Mention was made of the Banquet speaker, the banquet is normally comped for the speaker and his/her spouse plus the speaker fee.

- 3.6 Bulletin Editor Report:
- (1) <u>Printing issues</u>: Linda Elsnau reports her color printer no longer works, could not have the May *Bulletin* printed at Office Depot so it was printed on her home laser printer. Linda calculated that the cost is $9\phi/pg$. The June *Bulletin* printing cost for 14 copies was \$15.12.

- (1) <u>No official report</u> but Ann Meister will check with Al Wilkins and Bob Housley to set up a meeting (possibly in September) to discuss the next Pacific Micromount Conference;
- (2) Surge protectors: Rudy says he has about 10 extra surge protectors we can use for the next PMC;
- (3) <u>Chairs and Tables:</u> Discussion about chairs (stacking) at Costco (under \$500 for 14 pk) or U-line. May need a chair dolly for ease of storing/moving. The chairs need to be comfortable! As for tables, they need to be 6' but of what material? Ann will contact Jennifer at the San Bernardino County Museum for table specs and a room set-up template;
- (4) <u>MSSC labels</u> for chairs and tables: Discussion about label type and wording to be used: "Donated by MSSC and PMC" (spelled out) or? Plastic gummed labels are durable and foil is another option. Also, placement of labels on chairs and tables was discussed. Ann will check for more information and cost/pricing.

Because our picnic is a potluck, we don't need as much meat; people will be bringing other things. Rudy's budget last year was \$465. This year, Rudy will purchase and prepare a variety of meats including Tri-tip, racks of ribs, pork shoulder and brisket.
